### Rules and Vendor Requirements:

Spaces will be reserved on a first-come, first-serve basis, and will be assigned upon arrival. Set-up will be on Friday, May 21 from 10AM-2PM. No set up will be allowed before this time. Please check in at the vendor table (see attached map) so you can be assigned your space. All food vendors will be placed on a first-come, first-served basis in the "FOOD" area indicated on the map. Vendors will be completely set up and ready to conduct business by 4PM on Friday, and will not break down or leave until the festival is over at 10PM on Saturday. No vendor vehicles will be allowed in the festival area during the festival.

Vendors are to supply their own water, electricity, and trash cans/containers with trash bags. Trash containers will be emptied by festival staff throughout the day. Vendors will remove all trash from the ground in their space prior to leaving the festival area. Disregarding this requirement will result in application denial for further festivals.
